

Introduction

Race on the Agenda was set up in April 1997 to build on the work of GLARE (Greater London Action for Race Equality) which was established in June 1986. **ROTA** is a social policy think tank that works with London's Black, Asian and minority ethnic (BAME)¹ communities towards achieving social justice by the elimination of discrimination and promotion of diversity, human rights and equality of opportunity. We achieve these aims by informing London's strategic decision-makers about the issues affecting the BAME voluntary and community sector (VCS), the communities it serves and by making government policy more accessible to London's BAME organisations. MiNet, the regional BAME network joined **ROTA** in 2002. It focuses on strengthening the voice for London's BAME VCS in the development of regional policy.

The current key areas are:

- Crime and Antisocial Behaviour
- Culture
- Education
- Equalities and Human Rights
- Health and Social Services
- Regional Government
- Social Inclusion and Homelessness

we continued our work in partnership with other BAME organisations in London and Britain; the mainstream voluntary and community sector; funders and both the public and private sectors.

In 2006–2007 our work benefited from funding.



In 2006–2007 our work benefited from funding relationships with:

¹ ROTA uses the term BAME to refer to all groups who are discriminated against on the grounds of their race, culture, colour, nationality or religious practice. This definition includes but is not exclusive to those people of African, Asian, Caribbean, Irish, Jewish, Roma and South East Asian descent.

ROTA covered a variety of policy areas in 2006–2007 relating to issues that impact on BAME communities in London. Under Crime and Policing, the focus was on a working with young people in relation to guns, gangs and weapons for the Building Bridges Project, and developing our work on tackling race hate crime using restorative justice. We were involved in the work of the London Resettlement Board in developing strategies working with offenders that took on issues of race. Work also began on ensuring race issues were integral to community reassurance work in London through events and publications.

A lot of work has been carried out in relation to Equalities and Human Rights. We set up a partnership project on the new Commission for Equalities and Human Rights (CEHR), producing a briefing and a report as well as holding an event. The main aims were to ensure the voice of the voluntary and community sector is heard as the CEHR is set up; that the issues for London are taken on board and the CFHR involves the sector. We also completed a report on the role of London's Race Equalities Organisations in London in light of the intended changes with the development of the CEHR. This took **ROTA** back to its former role as GLARE (Greater London Action on Race Equality) when it was a network of Race Equality Council's in London. Key recommendations looked at using different models to deliver race equality services, regional representation and local delivery.

The London Regional Consortium of ChangeUp Equalities and Human Rights Sub-group was also based at **ROTA** all year although it is not a **ROTA** project as it covers all equalities areas. Dinah Cox, the Chief Executive has chaired it since its inception and wrote an update of the Gaps and Solutions report on infrastructure support for frontline equalities organisations. Barbara Nea came in as the Project Officer in January 2007 and quickly developed responses with the group to Capacitybuilders consultations on their development to 2014 and mainstreaming diversity. Dinah was also elected by the Third Sector Alliance of London Voluntary Service Council (LVSC) to become VCS representative on Board for Refugee Integration in London. There was no specialist education worker but we carried out some work linking the role of human rights and education.

In regard to Health and Social Care, the policy team worked with the Greater London Authority (GLA) and the London Health Commission developing projects on health inequality. Joint work was started with Age Concern London on Mental Health and BAME elders, looking to develop a conference. On the area of care provided to older people, the Head of Policy also gave written and oral evidence to the House of Commons Joint Parliamentary Committee on Human Rights on how to meet the needs of BAME elders more effectively.

The Homelessness project that **ROTA** runs as part of the Off the Streets and Into Work, Tackling Multiple Disadvantage (TMD) partnership started

to take more shape once the new Project Officer started in November. I 6 BAME homeless individuals were recruited to share their experiences and **ROTA** contributed to a TMD conference in Budapest on cross cutting themes around homelessness and disadvantage. We focused on the needs of homeless people for the August Supplement.

We continued our broader work around Regional Governance, which touches on many of our policy areas with many meetings with the GLA, Government Office for London (GOL), London Councils and the London Development Agency (LDA). In particular this year we were one of only two VCS representatives engaged in the early discussions on the change in Mayoral powers.

Other areas of policy we were engaged with were around Culture and Community Cohesion. There was our involvement in setting up the 2007 Bicentenary of the Abolition of the Trans-Atlantic Slave Trade Steering group with Museums Libraries Archives London and the Chief Executive was invited to join the Mayor's Heritage Diversity Task Force. Joint work was taken on with LVSC on influencing the work of the Commission on Integration and Community Cohesion to take into account the role of the VCS in meeting the needs of our diverse London communities. We also looked at the services of VCS organisations serving different BAME communities in the Supplement published in March.

As can be seen in this report this year saw **ROTA** produce **16 written reports**, briefings, consultation documents and articles in addition to our regular bi-annual editions of the journals Agenda and Supplement. A monthly newsletter began in September 2006 and **41 email bulletins** were sent to members. Four external publications included information on **ROTA**'s work. We held **12 Events** including conferences, seminars and focus groups. As well as contributing to 38 policy boards and steering groups we were asked to speak at external events on **15** occasions. Carlene Firmin, the office Administrator secured a regular spot on the internet radio station Colourful Radio to discuss issues relating to Race and social policy.

In terms of staffing, once DrTheo Gavrielides started as Head of Policy in June, there were only a few weeks in the year when staff posts were unfilled. A new post for the ChangeUp Equalities and Human Rights Sub-group was started in January. Unfortunately, one staff member failed to pass probation. There were two temporary staff helping to deliver a project and volunteers were involved in ROTA for the first time. Eight people volunteered from Olmec and the London School of Economics from July, and made a marvellous contribution to the work of the organisation.

Of the funders who are mentioned in these accounts Capacitybuilders, the Safer London Foundation, the Big Boost Fund, and V were supporting **ROTA** for the first time. The Association of London Government, the City Parochial Foundation, the Esmée Fairbairn Foundation, the European Social Fund and the Home Office were continuing to sustain our work. **ROTA**'s internal performance was also strengthened by the probono support of Caroline Emerton of Latham and Watkins who gave free legal advice on updating all internal policies and procedures and our contracts.

The decision from 2005–2006 to ensure **ROTA**'s information was accessible to all by opening up membership and making it free was acted on. Work started to improve the database and ensure membership information is updated. At year end the membership was 1,500 people, some of who have been actively engaged in **ROTA**'s work for which we are very grateful.

Finally we received two awards. The Path National Award for Best Business Partner 2006 and a runner up award to **MiNet** from London Voluntary Service Council in its Success Stories competition. Further details of the work follow.



Future Work

ROTA plans to continue the activities outlined above in the forthcoming years subject to satisfactory funding arrangements. During 2007–2008 we will build on our reputation for effective delivery by ensuring we provide relevant information, events, representation and network opportunities for London's BAME VCS and policy makers in the statutory sector. Where possible we will work in partnership to bring added depth and value to the projects we undertake.

We intend to:

- Identify key policy issues for London's BAME communities from the areas of Equalities and Human Rights, Crime and Anti-social Behaviour, Culture, Education, Homelessness, Health and Social services and Regional Government. We will disseminate information on the issues through:
 - Producing ten targeted email policy newsletters
- Producing four briefings on specific policy issues
- Producing two editions each of our journals
 Agenda and Supplement
- Producing two articles for external publications
- Holding 12 information and consultation events on key policy issues
- Complete our research project on BAME homelessness and further develop our research projects on hate crime and the impact of gun, gangs and weapons.
- Redress under representation of BAME issues at regional, sub regional and local policy level by working with London's BAMEVCS organisations and London's policy makers by:
- Speaking at twenty external policy events
- Sitting on at least twenty policy steering groups
- Develop **MiNet** by widening membership and re-engaging an Advisory Group.
- Complete development of our internal database to give us easier access to our membership by locality and area of work.
- Put in place recommendations from the environmental audit to improve our sustainability.
- Celebrate **ROTA**'s 10th anniversary.

Independent Auditor's Report

We report to you our opinion as to whether the financial statements give a true and fair view and are



Basis of opinion

We conducted our audit in accordance with United Kingdom Auditing Standards issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the accounts. It also includes an assessment of the significant estimates and judgements made by the trustees in the preparation of the accounts, and of whether the accounting policies are appropriate to the charity's circumstances, consistently applied and adequately disclosed.
